Large Cap Core Growth

MARKET REVIEW

Growth stocks led U.S. markets higher during the first quarter, with small cap growth securities broadly delivering the largest gains. The S&P 500® Index climbed 13.65%, rising across all sectors. Information technology (+19.86%), real estate (+17.54%), industrials (+17.21%), energy (+16.42%), and consumer discretionary (+15.73%) were the strongest sector performers.

The sharp rebound from the fourth quarter's steep losses was driven by marked improvement in investor sentiment. Fears of possible global recession gave way to enthusiasm around the Federal Reserve's (Fed) more accommodative monetary policy outlook, emerging indications of a potential U.S.-China trade deal, and continued signs that U.S. consumer financial health remained strong. Balance sheets improved, unemployment remained low, and inflation stayed in check. Still, the quarter's rally, much like the prior quarter's sell-off, was not the result of any real change in stock fundamentals, despite continued signs of late-cycle softening.

PERFORMANCE

For the quarter, the Silvant Large Cap Core Growth Strategy Composite's return of +11.41% (gross)/+11.21% (net) underperformed the S&P 500 Index's return of +13.65%. Financials, consumer discretionary, communication services, and information technology stock selection detracted the most from performance. Overweight industrials and information technology positions and an underweight consumer staples position were the largest positive contributors to returns.

Roper Technologies and Mastercard were among the strongest stock contributors.

- Diversified industrial conglomerate Roper Technologies outperformed on earnings and revenue strength. The rebound in oil prices also benefited the company's energy-focused segment. We continued to hold the stock as it has been a very reliable, consistent performer. The firm also has expanded more into software over the past few years.
- Payment network company Mastercard rose on higher-than-expected earnings and strong sector momentum. Investor enthusiasm about acquisitions in the payment processing industry also helped shares. We maintained our position as the company's economics remain very attractive, and we expect to see additional improved utilization as transactions continue to move toward online and digital payments.

CME Group and Cigna were among the largest stock detractors.

- Despite reporting solid earnings and revenue, options and futures exchange operator CME Group—a top performer last quarter—fell on investors’ lower trading levels as broad market volatility declined. We continued to hold the stock as our long-term outlook remains intact.
- Health insurance company Cigna lagged on broad industry weakness from increased headline risk. Shares were weighed down by growing political rhetoric around drug prices, the current pharmacy benefit manager model, Medicare-for-All, and other potential regulatory changes. We maintained our position based on the firm’s strong fundamentals as it remains unclear at this point whether any of these proposed reforms might start to gain real traction.

PORTFOLIO CHANGES

New purchases included Costco Wholesale, TJX Companies, and Merck & Co. Exits included Activision Blizzard, Chubb, and SunTrust Banks.

- We bought membership-only warehouse retailer Costco Wholesale and discount department store TJX Companies. Both companies offer attractive same-store sales and should continue to benefit from overall strong consumer health and robust spending.
- New purchase pharmaceutical company Merck offers an attractive pipeline of potential new treatments and continued success with its new cancer drug Keytruda, which is exceeding expectations.
- We sold video game company Activision Blizzard on its underperformance and increased competition within the segment.
- We exited insurer Chubb and bank holding company SunTrust Banks on likely net-interest margin pressures from the Fed’s more neutral interest-rate stance. SunTrust also offered an attractive exit price as the stock rose on the company’s announced merger with BB&T.

OUTLOOK

We remain cautiously optimistic in our outlook. Overall market signals continue to be slightly mixed, though without any major fundamental issues. Growth is clearly slowing, but a lower expansion rate makes sense ten years into the cycle. While manufacturing data has been softer, continued low interest rates and generally optimistic consumers (albeit still without any real wage gain momentum) should both offer solid tailwinds.

At this point, we expect current earnings to decelerate a bit, putting company guidance for the second half of the year in an even more critical light. Stocks should continue to offer decent growth potential, but we believe it will be increasingly important to focus in on companies that are best positioned to buck the broader slowing growth trend.

Silvant became an affiliate of Virtus effective June 1, 2017, when Virtus acquired RidgeWorth Capital Management LLC and RidgeWorth Investments ("RidgeWorth"). Silvant was created March 31, 2008, when all of the investment decision-makers associated with the growth equity investment strategies of RidgeWorth became employees of Silvant. The staff and decision making process remained intact and independent within Silvant. For composite reporting purposes, the Firm is defined as all equity portfolios managed by Silvant. - The Large Cap Core Growth composite includes fully discretionary investment accounts and registered and unregistered mutual funds managed in accordance with the large cap core growth equity style, with the objective of investing in in stocks with a competitive advantage, strong profitability metrics, above average free cash flow, above average operating margins and positive price trends. Under normal circumstances, Large Cap Core Growth Portfolios will have at least 80% of their assets invested in common stocks and other U.S. traded equity securities of Mid to large cap companies. U.S. traded equity securities may include American Depository Receipts ("ADR's"). Silvant considers large cap companies to be companies with market capitalizations similar to those of companies in the S&P 500® Index and the Russell 1000® Growth Index. Silvant will seek out securities it believes have strong business fundamentals, such as revenue growth, improving cash flows, increasing margins and positive earnings trends. The gross of fee return for the mutual funds is calculated by adding back the fund's published total operating expense ratio to the net of fee mutual fund performance. - The Large Cap Core Growth composite includes the performance of the equity portion of balanced accounts. Cash returns have been allocated using a predetermined cash allocation mix approach. Such "carve-outs" represent the following percentages of the total market value of the composite: 1.2% as of December 31, 2008, and less than 1% as of December 31, 2009. Beginning January 1, 2010, all equity segments are managed with their own cash balance.
- The benchmark for the Large Cap Core Growth composite is the S&P 500 Index, an unmanaged index of 500 selected common large capitalization stocks (most of which are listed on the New York Stock Exchange) that is often used as a measure of the U.S. stock market. The index is calculated on a total-return basis with dividends reinvested. Index returns do not reflect the deduction of any fees or expenses.
